The above Un-audited Financial Results of the Zen Technologies Limited ('the Company') have been prepared
in accordance with Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act,
2013 ("the Act") read with relevant rules issued thereunder, other accounting principles generally accepted in

India and guidelines issued by the Securities and Exchange Board of India ('SEBI').

2. The aforementioned results have been reviewed and recommended by the Audit Committee and subsequently

approved by the Board of Directors at its meeting held on 25 October 2025.

3. The entire operations of the Company relate to only one segment viz., Defence and Homeland. Hence

segmental reporting as per Ind AS 108 is not made.

4. The value of the orders on hand as at the standalone company level as at 30 September 2025, is Rs.484.51

Crores.

5. During the quarter ended 30 September, 2025, the Company has transferred 12,500 equity shares of face value

of Re. 1/- each, to the eligible employees of the Company, to whom the grants were issued earlier under Zen

Technologies Limited Employee Stock Option Plan-2021 ("the Scheme"), from Zen Technologies Limited

Employees Welfare Trust established for the purpose of implementing the scheme, upon completion of

respective vesting period as may be applicable as per the scheme.

6 In the standalone financial statements, the Company had adopted the policy of consolidating the ESOP Trust,

the related loan and advances appearing in the standalone financial statement of the Company were eliminated

and investment in own shares of the Company held by the trust is shown as treasury shares in "Other Equity".

7 Consequent to accounting for treasury shares in the Standalone financial statements, the weighted average

number of shares considered for computation of earnings per share (EPS) has reduced resulting into increase

in basic and diluted EPS.

Independent Auditor's Review Report on Interim Standalone Financial Results

To The Board of Directors Zen Technologies Limited

- We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of Zen
 Technologies Limited ("the Company") for the quarter and six months ended 30 September 2025 ("the
 Statement"), being submitted by the company pursuant to the requirements of Regulation 33 of the
 SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("the Listing
 Regulations").
- 2. The Statement which is the responsibility of the Company's management and approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India (ICAI). A review of interim financial information consists of making inquiries, primarily of Company's personnel responsible for financial and accounting matters and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing specified under Section 143(10) of the Companies Act, 2013 and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.
- 4. Based on our review conducted as stated in paragraph 3 above, nothing has come to our attention that causes us to believe that the Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standard and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstatement.



5. The Statement includes unaudited financial results of one branch whose interim financial results and other financial information reflect total revenues of Rs. Nil and Rs. Nil for the quarter ended 30 September 2025 and Six months ended 30 September 2025, total net loss of Rs. 6.79 lakhs and 16.21 Lakhs for the quarter ended 30 September 2025 and Six months ended 30th September 2025 and total comprehensive Income of Rs. 40.21 lakhs and 46.52 Lakhs for the quarter and six months ended 30 September 2025 respectively, as considered in the Statement which have not been reviewed by their branch auditor.

These unaudited financial results and other financial information of the said branch have been approved and furnished to us by the management. Our conclusion on the Statement is not modified in respect of this matter.

Notes to Consolidated Un-Audited Financial Results for the quarter and half year ended 30 September 2025.

- The above Un-audited Financial Results of the Zen Technologies Limited ('the Company') and its subsidiaries
 (collectively "the Group") have been prepared in accordance with Indian Accounting Standards (Ind AS)
 prescribed under Section 133 of the Companies Act, 2013 ("the Act") read with relevant rules issued
 thereunder, other accounting principles generally accepted in India and guidelines issued by the Securities and
 Exchange Board of India ('SEBI').
- The aforementioned results have been reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at its meeting held on 25 October 2025.
- The entire operations of the Group relate to only one segment viz., Defence and Homeland. Hence segmental reporting as per Ind AS 108 is not made.
- 4. The value of the orders on hand for the Group as at 30 September 2025, is Rs.675.04 Crores.
- 5. During the quarter ended 30 September 2025, the Group has transferred 12,500 equity shares of face value of Re. 1/- each, to the eligible employees of the Company, to whom the grants were issued earlier under Zen Technologies Limited Employee Stock Option Plan-2021 ("the Scheme"), from Zen Technologies Limited Employees Welfare Trust established for the purpose of implementing the scheme, upon completion of respective vesting period as may be applicable as per the scheme.
- 6. In the consolidated financial statements, the Group had adopted the policy of consolidating the ESOP Trust ("the Trust") with the consolidated financial results of the Group. In accordance with the policy the loans and advances of the ESOP Trust have been eliminated in these consolidated financial results and the investment in own shares of the Group held by the Trust are disclosed as treasury shares in "Other Equity".
- Consequent to accounting for treasury shares in the Standalone financial statements, the weighted average number of shares considered for computation of earnings per share (EPS) has reduced resulting into increase in basic and diluted EPS.
- 8. During the quarter, Zen Technologies Limited's shareholding in AI-Turing Technologies Private Limited (AI-Turing) reduced from 51% to 49% following the fresh issue of shares in AI-Turing to new investors. Due to this, Zen Technologies Limited has ceased to exercise control over AI-Turing within the meaning of Ind-AS 110, "Consolidated Financial Statements". Consequently, AI-Turing has been de-consolidated from the Group's consolidated financial statements and the resulting gain of Rs. 94.24 lakhs arising in loss of control in the subsidiary has been recognised in the Consolidated Statement of Profit and Loss under "Exceptional Item". The Group now holds a 49% equity interest, which is accounted for as an associate under Ind-AS 28, "Investments in Associates and Joint Ventures".

- 1. - 2.
